## From the CEO's Desk

Welcome to the Spring Edition of the "CCLO Catch Up!" By now we are all aware of the progress of the NDIS roll out over Australia and have seen some of the statistics from the NDIS trial sites. The closest trial site to us here on the Central Coast, being the "Hunter Trial Site". Even though the Central Coast is not in a trial site, CCLO has been accredited to NDIA and does support a client with funding through the NDIS and has done so since April this year.

The full NDIS implementation still has a long way to go but will provide funding on an individual basis to people with a disability and this funding will be based on the life choices made by them.

People with a disability will be encouraged and assisted to make their own choices about housing, community participation, employment and many other things that everyone else in the community takes for granted on a day to day basis.

The funding from NDIS when granted will be based around the "reasonable and necessary" support a disabled person needs to make choices and take control of their own lives.

The method of operation by groups such as our own will need to change as the people we support are given the option of making their own lifestyle decisions and how their NDIS payment will be spent.

As is the case, new programmes and ways of doing things can often be perplexing for staff, our clients and their families. We at CCLO are keen to work with all those involved as we work towards NDIS individual funding.

## A Message from the Board of Management

We are now up to the Spring Issue of "CCLO Catch Up", how very quickly time passes, and we are approaching our Annual General Meeting. This year it will be on 21st October at the Zenith Centre in the Tuggerah Business Park. You will receive full details of the meeting in due course, but please make a note of the date and try to attend. If you haven't already done so, it is now time to renew your membership.

One of the really important issues for the Board and Management is to continue to raise the public profile of CCLO and we have been concentrating on that in the last couple of months, particularly with regard to the political sphere. We had a visit from the local member of parliament for Wyong, David Harris at the end of June. He joined us for lunch at our Wakool House and inspected both Wakool and Lily Lane houses. He was very impressed with what we are doing in the disability sector. Following that, Kevin Johnston and I attended a business lunch with NSW State Treasurer Gladys Berejiklian where we were able to bring CCLO to her attention.

Following the announcement of an allocation in the NSW State Budget of \$150 million for 900 respite places and 310 supported accommodation places for people with a disability. we actively sought a meeting with State Minister for Disability Services, Mr John Ajaka. We were fortunate to have the Minister visit us in mid August, and he too inspected our facilities at Wakool and joined us for lunch. He met the residents and staff of Wakool, together with management staff. Again, the Minister expressed his support and approval of CCLO and its work with people with disabilites. The main aim of the meeting with the Minister Ajaka was to seek \$1m in government funding to complete construction of two new supported accommodation homes on CCLO land at Gorokan. We now have an approved DA for that project and we are ready to proceed immediately if we can get the funding. Sadly, the Minister did not bring the cheque with him, but we were promised that our project would receive attention at the highest ministerial and departmental level. We can now only hope for a good outcome.

As we go to print we are in the process of organising a visit from federal Senator Mitch Fifield, Assistant Minister for Social Services, who we hope will also visit Wakool. He will be on the Central Coast with federal MP Karen McNamara and Lucy Wicks MP.
